
Cyprus Tabletop Gaming Festival





Interpretation and General

- Cyprus Tabletop Gaming Festival (the "Event") is an annual tabletop gaming convention.
 The Event is organised by the directors of C.T.G. Cyprus Tabletop Gaming LTD (the
 "Organisers").
- 2. The Event takes place in Pavilion, 2 Avraam Antoniou, Lakatamia 2330, Nicosia, Cyprus (the "Venue").
- 3. By Participating in the Event or any part of the Event, each individual (each, a "Participant") acknowledges that they have read, understood, and agree to be bound by these Terms and Conditions.
- 4. As used herein, to "Participate" (or a Participant's "Participation") shall mean registering for, attending, accessing, entering or viewing the Event or any part of the Event, whether such Event is in a physical and/or digital format.

If any Participant does not agree to these Terms of Service, such Participant should not Participate in the Event.

In the event a Participant is a Minor (as defined herein), all uses of the term "Participant" in these Terms of Service shall also be deemed to include such Minor's Guardian (as defined herein).

- 5. In addition, every Participant will:
 - follow any instructions and comply with any reasonable requests made to the Participant in advance of or during the Event by the Organisers, or anyone acting as a Volunteer at the Event;
 - follow and act in accordance with any terms and conditions laid down by the management or staff of the Venue to the extent that they are communicated to the Participant either prior to or during the Event; and

c. comply with any reasonable instructions given to the Participant by the management or staff of the Venue either prior to or during the Event

as though any such terms and conditions or instructions were incorporated into these terms and conditions.

- 6. "Event Features" shall be defined as any panels, special events, education sessions, classes, performances, screenings, webinars, networking events, or other activities held by the Organisers (whether in-person or virtually) as part of the Event.
- 7. These terms and conditions shall be subject to the laws of Cyprus.
- 8. All matters and questions not covered by these terms are subject to the decision of the Organisers. Participants agree to abide by and conform to all additional rules and regulations adopted or prescribed by the Organisers for the management of the Event to the extent that such rules and regulations are shown or explained to the Participants.

At any time, the Organisers may amend these Terms and Conditions without notice to the Participant by posting the amended Terms and Conditions on the Event website. The continued Participation in the Event by a Participant shall constitute acceptance of any such amended Terms and Conditions.

Assumption of Risk and Release

Participant acknowledges that there are hazards and risks incidental to Participating in the Event. By accepting an Exhibitor's badge/lanyard (hereby defined as "Credentials") and/or by Participating in the Event, Participant freely and voluntarily assumes any and all risks which are incidental to the Event, regardless of severity and regardless of whether or not caused by the negligence of the Organisers, including, but not limited to, loss, property damage, injury or damage to persons and/or death.

 Further, Participant acknowledges that there is an inherent risk of exposure to communicable disease, including, but not limited to, COVID-19, in any public place where people are present, and, by Participating in the Event, Participant freely and voluntarily assumes any and all risks related to such exposure.

- Participant agrees to follow all health and safety instructions, guidelines, or standards
 issued by local, state, and federal governmental authorities, as well as any health and
 safety instructions, guidelines, or standards for the Event which may be posted on-site at
 the Venue, within the Platform (including on the Event website), or as otherwise provided
 to Participant by the Organisers.
- In consideration for Participating in the Event, Participant hereby releases and forever discharges the Organisers, the Venue, each of their parent, affiliated, and subsidiary companies, and each of their respective agents, employees, officers, directors, trustees, shareholders, contractors, sponsors and any third parties acting on their behalf (collectively, the "Released Parties") from any and all claims, actions, damages, liabilities, costs or expenses (including attorney fees) which are related to, arise from or out of, or are in any way connected to the Participant's Participation in the Event, whether or not such claims, actions, damages, liabilities, costs or expenses are caused by the negligence of the Released Parties or by the infringement or violation of any right. This release shall be effective and binding upon any heirs, agents, personal representatives or assigns of Participant (and of the Guardian if Participant is a Minor).

Access to the Event

Except as may be required by applicable law, Participant is solely responsible for ensuring that Participant is able to Participate in the Event, including, but not limited to, any requirements that the Organisers specify or make available on the Event website or at the Venue.

- 1. Everyone wishing to access the areas of the Venue in which the Event is being held must have a valid ticket, or Credentials.
- 2. Currently tickets may only be bought on the door, either with cash, credit or debit card payments.
- 3. Under no circumstances will refunds of entry tickets be made.
- 4. Anyone aged 13 or over must have an entry ticket in order to attend the event.
- 5. Children aged 12 or under do not have to pay for an entry ticket and will be given a free ticket on arrival at the Venue. This is on the basis that the child is accompanied by an

adult who has a valid entry ticket and who will remain with the child at all times during the Event. Furthermore, the accompanying adult will be responsible for ensuring the safety of the child at the Event and that it will comply with these terms and conditions.

- 6. Entry tickets are in the form of a wristband and must be worn in clear sight throughout the entire time that the attendee is at the Event. In addition:
 - a. Each entry ticket/wristband admits one person only;
 - The re-selling of entry tickets/wristbands is strictly prohibited unless the seller has been given explicitly written permission from the Organisers;
 - c. Counterfeit wristbands and their unauthorised sale are strictly prohibited and constitute an immediate forfeiture of the involved parties' access to the Event, including future editions of the Event.
- 7. Exhibitor Credentials must also be worn by Exhibitors at all times.

Personal Property

Upon entry to any portions of the Event held in the Venue, all participants, their bags and other personal property may be subject to screening or security checks. The Organisers expressly reserve the right to prohibit any personal property from entry into the Venue.

All personal property brought to the Event is done so at Participant's own risk and Participant is responsible for safeguarding such property at all times. Participant hereby acknowledges and agrees that the Organisers are not responsible for, and shall have no liability resulting from, any loss or damage to any personal property belonging to Participant, including, but not limited to, loss or damage resulting from fire, storms, acts of God, air conditioning or heating failure, theft, pilferage, bomb threats, roof leaks, other attendees participating in the Event or other causes, to the extent consistent with applicable law.

No personal property may be left unattended while in or around the Venue. The Organisers will handle unattended property however the Organisers deem appropriate in their sole and absolute discretion. Any personal property which is left within the Venue upon the conclusion of the Event shall be considered abandoned and handled by the Organisers accordingly.

Proper Attire

At all times in connection with the Event, Participant will wear proper attire, including shoes and shirts. The Organisers reserve the right to deny access or remove from the Event any participant wearing inappropriate attire or attire that could detract from the Event overall, in the Organisers' sole and absolute discretion.

Event Policies and Code of Conduct

At all times in connection with the Event, Participant is required to comply with and behave in accordance with:

- these Terms and Conditions;
- all applicable laws, ordinances, codes, regulations, standards and judicial or administrative orders;
- any additional Event rules, regulations, codes of conduct, policies, terms of use or
 procedures which may be posted at the Venue, on the Event's website and social media
 profiles, or otherwise distributed to Participants by the Organisers and as may be
 updated from time to time by the Organisers (collectively, the "Event Policies").

By Participating in the Event, Participant acknowledges and agrees that Participant has read, agrees to comply with, and will behave in accordance with the Event Policies.

The Event Policies apply to everyone Participating in the Event in any manner whatsoever, including, but not limited to, all Participants, exhibitors, attendees, speakers, guests, professionals, media, staff members, workers, contractors, vendors, volunteers, security or anyone else Participating in any way. Each Participant is solely responsible for their own conduct while Participating in the Event or any part of the Event. Guardians are solely responsible for the conduct of any Minors Participating in the Event or any part of the Event.

As part of the Event Policies, each Participant agrees that they will not, and will not directly or indirectly cause others to, do any of the following "Prohibited Activities" in connection with the Event:

i. interfere with, damage, or engage in any act which disrupts the operation of the Event in any way, including but not limited to, obstructing aisles or entrances or exits, running, cutting in line, saving places in lines for others, jumping over barriers or guardrails, using

foul language, screaming, yelling, encouraging disruptive behaviour from others, disobeying any time limits, directions or prohibitions provided to Participant by the Organisers, the Volunteers, the Venue staff and/or moderators, or preventing any other participant from Participating in the Event by any means;

- ii. distribute, wear, transmit, upload, display or otherwise circulate any content which is inaccurate, unlawful, infringing, defamatory, obscene, pornographic, invasive of privacy or publicity rights, harassing, threatening, abusive, inflammatory, or otherwise objectionable to the Organisers in the Organisers' sole discretion;
- iii. distribute printed or recorded materials of any kind unless prior written approval has been obtained from the Organisers;
- iv. impersonate any other person or entity or perform any similar fraudulent activities;
- v. sell goods or services, display goods or services, make solicitations of any kind, or conduct any commercial activities without the prior written approval of the Organisers or the appropriate Credentials;
- vi. harvest, collect, or attempt to collect the personal information, email addresses or other contact information of other participants in the Event without the consent of such participants;
- vii. defame, harass, abuse, threaten or defraud other participants in the Event.
- viii. circumvent, disable, damage, remove or otherwise interfere with the security, integrity, or proper conduct of the Event;
- ix. access any unauthorised part of the Event designated as only for Organiser, Volunteer or Venue staff use;
- x. access the Platform by means of any robot, spider, scraper, crawler or other automated means for any purpose;
- xi. Participate in the Event for any illegal purpose, or in violation of any applicable local, state, national, or international law or regulation, including, without limitation, laws governing intellectual property and other proprietary rights, data protection and privacy;
- xii. smoke within the Venue, which includes, but is not limited to, cigarettes and vape pens;

- xiii. drink or possess alcohol within the Venue outside of the specifically designated areas.

 No one under the age of 18 may consume alcohol within or around the Venue;
- xiv. use, sell, possess, or distribute any illegal drugs or other illegal substances, including, but not limited to, any medication that has not been legally obtained, is not being used in its intended dosage or for its intended purpose;
- xv. assault, steal, fight, engage in or incite violence of any kind, including, but not limited to, verbal threats of violence; and
- xvi. possess and/or use any of the following prohibited items in connection with the Event:
 - a firearm, ammunition, knife, or weapon of any kind;
 - objects or toys that appear to be firearms, ammunition, knives, or weapons;
 - self-defence or restraining devices;
 - fireworks or other explosive or flammable objects;
 - glass containers;
 - recreational devices such as drones, remote control toys, skateboards, scooters, inline skates or shoes with built-in wheels;
 - folding chairs;

Pet Policy

Pets are <u>not</u> allowed at the Venue during the hours of the Event, with the exception of service animals as defined by Cyprus' Equality Act 2010. A service animal is either:

- 1. trained to perform functions to assist a person with a disability, or
- 2. has the ability to assist a person with a disability.

Service animals perform many disability-related functions, including but not limited to:

- guiding individuals who are blind or have low vision;
- alerting individuals who are deaf or hard of hearing to sounds;
- assisting epileptic or autistic individuals;

- pulling a wheelchair;
- alerting persons to impending seizures.

Please note that while emotional support or comfort animals may well provide a benefit to the individual, for the occurrence of the Event, they are not considered service animals. Service animals have been specifically trained to recognise a condition, behaviour or situation, and also trained to respond or perform specific tasks that aid the disabled person.

The Organisers **only allow dogs as service animals**, provided the Participant accompanied by the service animal hereby agrees to the following:

- The service animal must not pose a direct threat to the health or safety of others.
- It shall not pose a threat of disruption to the Event activities.
- It will not roam around the Venue or leave the Participant's side at any point during the Event.

Dogs that are not trained to perform tasks that mitigate the effects of a disability and any animal that is used purely for emotional support, comfort, or companionship are not allowed on the Venue premises.

Sanctions

If the Organisers in their absolute discretion, consider that any Participant has materials with them or is acting in a way which;

- poses risks to the health and safety of others attending the Event; and/or
- contravene the terms and conditions of the Venue as appropriate; and/or
- may cause damage to the structure or any part of the fabric of the Venue; and/or
- are likely to cause offence or distress to others attending the Event and/or
- are unsuitable for an Event aimed at a family audience and attended by small children,
- a. The Organisers will request the Participant to cease any such activities and remove any offending items from the Venue
- b. If a Participant fails to cease any such activities or remove any such offending items when requested to do so, the Organisers may take whatever action they deem appropriate up to and including ejecting the Participant from the Event.

c. The Organisers reserve the right to refuse admission to any Participant if they in their absolute discretion decide the Participant is inappropriately clothed or attempting to use materials or perform actions of a dangerous or objectionable nature.

Security

The Organisers reserve the right to modify, suspend, extend or terminate the Event, or any part thereof, or any Participant's Participation thereto if the Organisers determine, in their sole and absolute discretion, that the Event or any part thereof has been, or is suspected to be, tampered with or disrupted due to causes beyond the Organisers' control in a manner which may undermine or corrupt the security, integrity or feasibility of the Event or any portion thereof as contemplated herein. Although the Organisers shall endeavour to ensure the security and integrity of the Event, in the event the Event or any part thereof is terminated or has any change in date, time, or location, for any reason beyond the Organisers' control, the Organisers shall not be liable to Participant in any way and the Organisers shall have no further financial obligations to Participant.

Additionally, the Organisers are not responsible for the actions of any other Event participants in connection with the Event, including, but not limited to, any participant's attempt to circumvent or otherwise interfere with the security, integrity, or proper conduct of the Event. Participant's interactions with third parties, including, but not limited to, guests and other participants in connection with the Event, are solely between Participant and such third party. Participant acknowledges and agrees that the Organisers will not be responsible for any damages, losses, costs, expenses, or liabilities incurred as the result of such interactions with third parties. The Organisers are also not responsible for any problems or technical malfunction of any network or lines, servers or providers, equipment or software which are beyond the Organisers' control, including, but not limited to, any injury or damage to Participant or Participant's property resulting from Participation in the Event.

Cancellation Policy

The Organisers reserve the right to cancel or postpone the Event, or any part of the Event, on limited or no notice in the Organisers' sole discretion. In the event of a cancellation or postponement of the Event, the Organisers shall not be responsible or liable for any costs, damages, fees, expenses or other compensation associated with the Event.

Intellectual Property Rights

1. Release of Likeness

For good and valuable consideration, and in exchange for the opportunity to Participate in the Event, Participant hereby authorises, permits, and grants to the Event, its parents, affiliates, sublicensees, designees, agents and assignees (including, without limitation, any sponsors, exhibitors or contractors to the Event), and each of their respective assignees, sublicensees and successors, the royalty-free, absolute and irrevocable right and licence to:

- a) record, photograph, and/or film the likeness, voice, appearance and/or image of such Participant while Participating in the Event (collectively, the "Likeness"); and
- b) publish, reproduce, portray, distribute and/or otherwise use the Likeness in all media formats (whether now known or hereafter existing), worldwide, solely in connection with the distribution, promotion and publicity of both the Event (including future editions thereof) and the Organisers' general business, services or products.

2. Release of Participant Content

From time to time, certain parts of the Event may allow Participants to submit, share, post, create, or otherwise distribute (collectively, "Distribute" or "Distributing") content, which may include, but is not limited to messages, text, sound, images, videos, data or other materials originating with Participant (collectively, the "Participant Content").

For good and valuable consideration, and in exchange for the opportunity to Participate in the Event, Participant acknowledges that by Distributing any Participant Content as part of the Event, whether to the Organisers directly, to their assignees, sublicensees and successors, on the Event website, or at the Venue generally, Participant thereby authorises, permits, and grants to the Organisers and their assignees, sublicensees and successors a royalty-free, irrevocable, non-exclusive, sublicensable, assignable, unrestricted right and licence to publish, reproduce, portray, modify, adapt, transmit, distribute, create derivative works from, and/or otherwise use the Participant Content in all media formats (whether now known or hereafter existing), worldwide, solely in

connection with the distribution, promotion and publicity of both the Event (including future editions thereof) and Organisers' general business, services or products.

Please note that any Participant Content is Distributed solely at Participant's own risk. To the furthest extent permitted by applicable law, Participant hereby agrees that the Organisers shall not be liable for any unauthorised copying, use, disclosure or distribution of any Participant Content by third parties and Participant releases and forever waives any claims against the Organisers for any such unauthorised copying or usage of the Participant Content under any theory.

To the fullest extent permitted by applicable law, the Organisers reserve the right to remove, discard, screen or edit any Participant Content at any time without notice to Participant in the Organisers' sole discretion and without any liability to Participant whatsoever. While the Organisers have no obligation to monitor any Participant Content, the Organisers reserve the right to do so and reserve the right to enforce the intellectual property rights of the Organisers or of any third party.

3. Representations and Warranties Regarding Intellectual Property

The "Likeness" and all "Participant Content" shall collectively be defined as a Participant's "Intellectual Property." With respect to such Intellectual Property, Participant represents and warrants that:

- a) Participant is the creator and owner of any Intellectual Property hereunder, or otherwise has obtained the necessary rights and authority to grant the rights described herein;
- b) to the extent the Intellectual Property contains the Likeness, name, marks, and/or other biographical or identifying information of Participant or of any third parties, Participant consents (or has obtained the required consents and/or licences from any third parties) to the use of such Intellectual Property by the Organisers, their assignees, sublicensees and successors, solely as described in these Terms of Service;
- the Organisers, their assignees, sublicensees and successors may exercise the rights granted herein to the Intellectual Property without any additional financial liability, including, but not limited to, any compensation, royalties, residuals, or

fees to Participant or any relevant third party. Any claims for additional payment for the Organisers' or their assignees, sublicensees and successors' use of the Intellectual Property (as described in these Terms of Service) in any media is expressly waived;

- d) Participant shall have no ownership in any media created by the Organisers which incorporates the Intellectual Property (provided that Participant shall retain any ownership of any underlying Intellectual Property itself);
- e) there shall be no expectation of any attribution to Participant;
- f) the Organisers, their assignees, sublicensees and successors may use the Intellectual Property in any manner or media without first notifying Participant or any third party and Participant hereby waives any right to inspect or approve any such use;
- g) in connection with the Organisers' use of the Intellectual Property, Participant releases each of the Organisers, their assignees, sublicensees and successors from any claims, causes of action, damages or liabilities which Participant may have in connection with the Intellectual Property, including, but not limited to, any moral rights or "droits moral" that Participant may have;
- h) any digital Intellectual Property does not contain any viruses, adware, spyware, worms, bombs, or other harmful or malicious code;
- i) the Intellectual Property does not, and the use of the Intellectual Property by the Organisers and their assignees, sublicensees and successors will not:
 - infringe, violate, or misappropriate any third-party rights or proprietary rights; or
 - o defame or slander any other person or legal entity; and
- j) the Intellectual Property will not violate any applicable laws or regulations.

The Organisers reserve all rights and remedies against any participants who breach or violate these representations and warranties. The Organisers are not liable for any Intellectual Property or for any loss or damage resulting therefrom and the Organisers are under no obligation to store or return any Intellectual Property. While the Organisers

take reasonable security measures in connection with the Event, the Organisers do not guarantee the safety of any Intellectual Property and have no responsibility to do so.

4. Acknowledgement

Participant agrees and acknowledges they have read and understood this "Intellectual Property Rights" section and hereby expressly approves and consents to its terms, affirms their right and authority to agree to such terms, and waives all obligations and rights which such individual may have in connection therewith.

For good and valuable consideration, for any Minor Participants, the Guardian hereby guarantees that the Minor shall not at any time disaffirm the release of the Intellectual Property by reason of the Minor's minority or otherwise and hereby agrees to indemnify the Organisers from any loss arising from any claims made by or on behalf of the Minors relating to this release.

Health & Safety

Please be advised that a risk of exposure to communicable disease, including COVID-19, exists in any event or public space, including the Event. Prior to registering for and attending the Event, each Participant must ensure they have read the latest public health guidance for the location of the Event. By attending the Event, Participant acknowledges this inherent risk on behalf of Participant and/or any Minor attending the Event for which Participant serves as Guardian (collectively, "You") and, as a condition of entering the Event, You acknowledge, understand and confirm that You will abide by all terms of admission and participation (as may be updated from time to time) and Event health-and-safety requirements, all local public health regulations and guidance from the relevant city and/or state which are in effect at the time of entry, and, where applicable, provide proof of compliance with any Event entry requirements.

Limitation of Liability

Participant agrees that Participation in and to the Event, including any security measures used by the Organisers to protect the Event, are provided strictly on an "as-is" basis. In connection with the Event, the Organisers specifically and expressly disclaim any and all representations, warranties, guarantees, conditions, assurances or other terms, whether express or implied,

including without limitation, any representations or warranties of merchantability or fitness for a particular purpose, any warranties that may arise from course of dealing, course of performance or usage of trade with respect to the Event, and any representations that the Event or the security measures for the Event will be free from defects, operate or be fulfilled without issue or delays, or that there will be no circumvention of the Event or its security measures.

If any applicable authority holds any portion of this section to be unenforceable, then the Released Parties' liability will be limited to the fullest possible extent permitted by applicable law. Without limiting the foregoing, under no circumstances shall the Organisers be liable for any claim, loss, cost, expense, or damage whatsoever to Participant in an amount exceeding the sum of the fees actually paid to Participate in the Event.

Acknowledgment of Terms of Service

By Participating in the Event, Participant acknowledges and agrees that Participant has read, and agrees to comply with, the Terms and Conditions stated herein and agrees that these terms shall be construed by and governed in accordance with the laws of Cyprus and that, with respect to any dispute arising out of these terms, the sole and exclusive jurisdiction and venue shall lie with the state and federal courts located in Cyprus.

Except where prohibited by applicable, Participant acknowledges and agrees that any and all disputes, claims, and causes of action arising out of or connected with these Terms and Conditions or with the Event shall be resolved individually, without resort to any form of class action. For the avoidance of doubt, registration for the Event, Participation in the Event, and/or the purchase or use of Credentials shall be considered acknowledgement of, and agreement to, these Terms and Conditions.

Authority

The Organisers shall have sole authority over all aspects of the planning, promotion, production and operation of the Event, including without limitation, determining the Venue, scheduling, rescheduling, and if, when and for how long the Event will occur.

Reservation of Rights; No Waiver

The Organisers reserve all rights not expressly disclaimed in these Terms and Conditions. The Organisers reserve the right to take any action that is reasonably necessary in the sole judgement of the Organisers for the protection of the Event and/or the participants. Neither the failure of the Organisers to require strict compliance with any provision of these Terms and Conditions, nor the failure, delay or omission by the Organisers in exercising any right with respect to any provision of these Terms and Conditions will be construed as a waiver or relinquishment to any extent of the Organisers' right to assert or rely upon any such provision or right in that or any other instance.

Any provision of these Terms and Conditions which imposes an obligation on a Participant after the Event concludes shall be deemed to survive the conclusion of the Event.
